Fresh water flush; r&r oil & oil filters (4-stroke only); r&r fuel filters (does not include VST); run engine on fuel/stabilizer mix; fog w/storage lube; drain, pressure test & refill lower gearcase; grease all fittings.

Run engine to temp & flush with fresh water; remove/replace oil & oil filters; treat fuel/stabilize system & remove/replace fuel filters.

Inspect yoke; clean pitot; remove props; inspect, clean & grease shaft; drain gear lube, pressure test & refill; sand drive; apply primer & anti-foul paint; install new zincs.

All services must be guaranteed with a major credit card. Services are due upon completion and will be considered past due after 10 days. Finance charges will occur at a rate of 1.5% per month on all past due accounts. I hereby give my permission for my credit card to be processed.
